SERVICES & PROVISIONS AGREEMENT

This Agreement is entered into between **JS Outdoors**, hereinafter referred to as "OUTFITTER," having its primary place of business at 133 La Senda Road, Los Alamos, New Mexico, 87544 and its employees and (_____) hereinafter referred to as "HUNTER." The Parties identified above shall hereinafter be referred to as "Parties" to this Agreement (each referred to as "Party").

1. The effective date of this Agreement will be the latter date of signature below by the Parties above and shall be hereinafter referred to as "EFFECTIVE DATE."
2. For the services below by OUTFITTER, its employees, agents or subcontractors, the HUNTER agrees to the following terms and conditions of this Agreement:

- a) Game tags provided by OUTFITTER:

The OUTFITTER will apply for game tag(s) for the hunts provided by OUTFITTER through the applicable state's Department of Game and Fish. The HUNTER recognizes and acknowledges that any fees for these game tags are separate from the FEE FOR SERVICE charged by OUTFITTER and will be reflected accordingly in the Invoice document provided by OUTFITTER to HUNTER after the applicable big game draw results are posted for the total fees and charges owed to OUTFITTER for the designated hunt. OUTFITTER may also purchase private landowner game tags for HUNTER depending on availability of such private landowner game tags. Provisions for purchase of such tags is specified, if applicable, in Appendix A of this Agreement. HUNTER recognizes and acknowledges that any fees for these game tags are separate from the FEE FOR SERVICE charged by OUTFITTER.

- b) Amenities Provided by OUTFITTER

- i. All Hunts

Outfitter will provide, 2x1 HUNTER to guide ratio (1x1 HUNTER to guide ratio available for additional cost), 3 meals per day provided by cook, field care of game and meat retrieval, transportation during hunt, land use permits, comfortable camp accommodations to include; tents with heating stoves, cots, and access to toilet and shower facilities.

- ii. Valles Caldera National Preserve (VCNP) Hunts

Accommodations for VCNP hunts will be upgraded and include a 1x1 HUNTER to guide ratio.

3. The OUTFITTER will refund ninety percent (90%) of the total amount of FEE FOR SERVICES paid by HUNTER up to thirty (30) days prior to the first day of the hunt, as specified by the applicable state's Game and Fish Annual Proclamation for the specific hunt for which the HUNTER possesses a tag or private landowner game tag minus the applicable tag fee and /or landowner fee. If the HUNTER cancels with the OUTFITTER five (5) or less days prior to the first day of the hunt for which he or she possesses a game tag, then the HUNTER forfeits the total FEE FOR SERVICE in its entirety paid by the HUNTER to the OUTFITTER.

This Agreement shall be construed and interpreted in accordance with the laws of the State of New Mexico, U.S.A, unless other choice of law restrictions prevent or impede such interpretation or execution.

By HUNTER and OUTFITTER signing into this Agreement, it is agreed that, in addition to the criteria listed in this Agreement, both Parties behave ethically, honestly, and safely.

Furthermore, in accordance with Federal law and U.S. Department of Agriculture policy, OUTFITTER is prohibited from discriminating on the basis of race, color, national origin, sex, age, religion or disability.
